MIXING

Shake well before using. For best results use full strength. Also, use full strength when using a floor scrubbing machine. For lighter stains, Ultra-Clean may be diluted with water. Experiment on a small test area to determine best dilution ratio for specific job.

APPLICATION

Apply Ultra-Clean and allow to stand for 5 minutes then scrub to loosen oils, grease, dirt and grime. Flush area with plenty of water. Remove any residue with a mop, squeegee or commercial vacuum. Rinse or mop surface clean with water. Any remaining residue left behind may prevent the penetration and/or bonding of any subsequent protective sealants or coatings. Reapply to areas where stains remain or where heavy accumulations of oil, grease or grime may have occurred.

COVERAGE

Approximate coverage is 200 ft² per gallon. Coverages will vary depending on the porosity of the surface.

Soak dirty tools in a tray or in a bucket of undiluted Ultra-Clean. Rinse with clean water.
